Call to Order – Dave Norton, Valna Wilson, Joanne Johnson, Karen McClelland and Melina Fuhrmann present.

Also present and participating in the meeting: Jennifer Bartos, District Clerk/Administrator, Improvement District Services, Inc.; Eric Price, Price Landscaping; John Leslie, Field Superintendent.

1. Discussion and possible action regarding field reports from Price Landscaping. Representatives of Price Landscaping may be called upon to speak.

Eric Price said there is nothing new to report and that things are moving along as planned. Price Landscaping was authorized to move forward with the dual weed barrier test.
