- Discussion and possible action regarding the Fiscal Year 21/22 Budget, Rates and Fees.
 The budget line items were reviewed. Director Mahon requested reconciliation reports be sent to her and Vice-Chair Kaplan. A line item for Redundancy was requested for \$25,000. The tentative budget will be adopted at the May meeting.
- Discussion and possible action regarding Ordinance amendments.
 Director Breuer requested an amendment that would remove any reference to dollar amounts and replace with "In accordance with the most recent Resolution." Jennifer will review the Ordinance and give the Board an estimate on what the cost might be to publish all amendments.
